#### DIRECTIONS:

**FOR GENERAL APPLICATIONS:** Generously sprinkle around flowers, shrubs, trees and more to keep animals from browsing.

**FOR PERIMETER APPLICATIONS:** Apply a 16" wide strip of repellent around area to be protected. Interior strips should also be applied every 5' on beds larger than 8' x 10'. Larger herbivores (deer, elk, moose) may require a heavier application rates than for smaller herbivores (rabbits, hares, groundhogs, opossums). Reapply every 30 days and immediately after heavy or prolonged rains. In areas of intense animal population and/or severe weather conditions, reapply as needed. Will not harm or burn plants.
