SHAKE WELL BEFORE USING

INDOORS

1. Test surface areas before spraying. Clean surface well and remove exposed food sources.
2. Lightly spray troublesome areas, corners and crevices. Repeat again in 2 days. Thereafter, monthly or as needed.

DIRECTIONS

To Repel: Liberally spray foundations and entry points to repel ants. Reapply as needed.

To Kill: Pour directly on ant mounds, drenching soil thoroughly. Depending on the depth of the nest, a repeat application may be necessary.
